

## Admissions Policy for 2027 Entry

Admissions Criteria	<p>Bishop Vesey's Grammar School is an Academy for boys aged 11-16 years with a co-educational Sixth Form and is designated as a selective grammar school under S104 of the School Standards and Framework Act 1998. The school is part of 'The Grammar Schools of Birmingham' Consortium.</p> <p>Admission to the School in Year 7 will be determined by a child's performance in the Entrance Test (sometimes referred to as "the 11+" or "the selection test") and the School's oversubscription criteria. The Governing Body participates in Birmingham City Council's coordinated admissions scheme for maintained secondary schools, and the 'Grammar Schools of Birmingham' Consortium is contracted to administer the Year 7 Admissions Policy and procedures on the school's behalf.</p> <p>Since Bishop Vesey's Grammar School is a single sex boys' school, eligibility for entry in Year 7 will be based on the child's biological sex being male.</p> <p>Only boys therefore who attain the required standard in the prescribed arrangements for selection are eligible to be considered for admission to the school. These arrangements require that prospective pupils are considered for admission based on a combined score, standardised according to the age of the child, on standardised tests of verbal, numerical and non-verbal reasoning ability.</p> <p>Boys born between 1 September 2015 and 31 August 2016 are eligible to apply for admission in Year 7 in September 2027.</p> <p>Priority for admission is given to children meeting the qualifying score resident within Zone 1. Zone 1 is determined as a straight-line measurement of up to 12 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School.</p> <p>Evidence will be required to prove that the child is resident within Zone 1 by the deadline of October 31<sup>st</sup> 2026. Birmingham City Council Admissions will require, on behalf of the School, evidence of the applicant's home address. Parents/carers will be notified each time this is required. The Admissions Service may also carry out a home visit to the family to further verify an applicant's address. The school reserves the right to withdraw the offer of a place if it is satisfied that the offer has been made based on an incorrect, fraudulent or misleading application.</p>

If we have not allocated all places to children resident in Zone 1, we will offer places to children resident in Zone 2, who attain the qualifying score. Zone 2 is determined as a straight-line measurement of between 12 miles and 20 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School

If we have not allocated all places to children resident in Zone 1 or 2, we will offer places to children in Zone 3. Zone 3 is determined as a straight-line measurement of beyond 20 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School.

In order to be eligible for admission to the school, candidates must achieve a minimum standardised score (the 'qualifying score') in the selection test. Where the number of applications for admission exceeds the number of places available at the school, places are offered to children as follows:

1. Looked After Children/Previously Looked After Children/ Internationally Adopted Previously Looked After Children who achieve the qualifying score by rank order of standardised score
2. Children, living in Zone 1, attracting the Pupil Premium who achieve the qualifying score by rank order of standardised score but limited to no more than 38 children in this category. (Please note that if we do not fill all 38 Pupil Premium places from Zone 1, we will offer places by rank order of standardised score to Pupil Premium children from Zone 2. If we do not fill all 38 Pupil Premium places from Zone 1 and Zone 2, we will offer places to Pupil Premium children by rank order of standardised score from Zone 3.)
3. Other children who achieve the qualifying score by rank order of standardised score living within Zone 1, which is a straight-line measurement of up to 12 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School.
4. Other children who achieve the qualifying score by rank order of standardised score living in Zone 2, which is determined as a straight-line measurement of between 12 miles and 20 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School
5. If we have not allocated all places to children resident in Zone 1 or 2, we will offer places to children resident in Zone 3 by rank order of standardised score. Zone 3 is determined as a straight-line measurement of beyond 20 miles, from where the child is resident, to the foot of the steps leading to the main school entrance of Bishop Vesey's Grammar School.
6. Where children are equal on standardised score, places will be offered to those who live nearest the school. Distances are calculated based on a straight-line measurement between the applicant's home address and the foot of the steps leading to the main school entrance. Birmingham Local Authority uses a computerised system, called Cartology, which measures all

	<p>distances in metres. Ordnance Survey supply the co-ordinates that are used to plot an applicant's home address within this system.</p>
Children with an Education Health and Care Plan	<p>Those who have an Education Health and Care Plan naming the school, and meeting the qualifying score will be allocated a place. This gives such children with a qualifying score overall priority for admission to the named school. This is not an oversubscription criterion.</p>
Looked after or previously looked after	<p>A child who is looked after or previously looked after</p> <p>A child who is looked after is a child who is in the care of a local authority or being provided with accommodation by a local authority in the exercise of their social services functions (see the definition in Section 22(1) of the Children Act 1989).</p> <p>A child previously looked after is a child who, immediately after being looked after, became subject to an adoption, child arrangement order, or special guardianship order.</p> <p>Internationally Looked After/Previously Looked After children are those children who appear (to the admission authority) to have been in state care outside of England and ceased to be in state care as a result of being adopted.</p> <p>In the case of children previously looked after, admission authorities may request a copy of the adoption order, child arrangement order or special guardianship order and a letter from the local authority that last looked after the child confirming that he was looked after immediately prior to that order being made.</p>
Pupil Premium	<p>Children attracting Pupil Premium</p> <p>Children attracting Pupil Premium are those who meet the Government's criteria for Pupil Premium and whose primary school is in receipt of Pupil Premium funding for them at the time of the entrance test. If unsure of eligibility, parents/carers are advised to check the gov.uk website.</p> <p>The school will require evidence of Pupil Premium registration and reserves the right to withdraw the offer of a place if the offer has been made because of an incorrect, fraudulent or misleading application.</p> <p>Parents/carers of children attracting Pupil Premium must have ticked the Pupil Premium box when registering their child for the test. Any alterations to this box cannot be made after submitting your selective test form. The deadline to submit your selective test form is 26th June 2026 at 4pm.</p> <p>Parents/carers must submit a completed Pupil Premium eligibility form before the day of the entrance test and any evidence received after this date will be considered as late, and will be considered after the main round of allocations has been made in March 2027.</p>

Reasonable adjustments/earlier registration deadline	<p>In accordance with the Equality Act 2010, Bishop Vesey's Grammar School will consider requests for adjustments to the entrance test from parents/carers of a child with a disability who wishes to attend the school.</p> <p>An additional form must be completed by 12<sup>th</sup> June 2026, along with relevant medical evidence and information from the current primary school. An independent specialist panel will consider the information submitted to decide whether reasonable adjustments should be made for the candidate.</p>
How and when to register for the entrance test	<p>Test registration is made via the <a href="#">West Midlands Grammar Schools website</a>.</p> <p>Test registration is made electronically and must be submitted by 4pm on 26<sup>th</sup> June 2026.</p>
Shared responsibility	<p>Where parents have shared responsibility for a child, and the child lives with both parents for part of the week, then the main residence will be determined as the address where the child lives the majority of the week. Parents may be requested to supply documentary evidence to support the address used.</p>
Separating 'final qualifier' applications (twins, blocks of flats etc)	<p>In a very small number of cases, it may not be possible to decide between the applications of those children who are the final qualifiers for a place, when applying the published admission criteria.</p> <p>For example, this may occur when children in the same year group live at the same address, or where there are twins, or if the distance between the home and school is the same, for example, blocks of flats. If there is no other way of separating the application according to the admissions criteria and to admit both or all the children would cause the legal limit to be exceeded, the local authority will use a computerised system to randomly select the child to be offered the final place.</p>
Applicants out of chronological age group	<p>Although most boys will be admitted to the school within their own age group, the school will consider requests from parents for their child(ren) to be educated outside of their normal age group. Parents are advised to contact the school to discuss such a request and submit any relevant evidence with their formal application. The decision whether to offer a place out of year group rests with the school and decisions will be taken in line with the School Admissions Code. Parents will have a right to appeal if a place is refused at the school. Parents do not have a right to appeal if a place is offered in a year group other than the year group for which they applied.</p>
Local authority fair access arrangements	<p>The school also participates in the local authority's fair access arrangements and this may require the school to offer a place in a year group even where the school is full.</p>
Exceptional circumstances (those who miss the test registration deadline)	<p>Candidates who are not registered by the deadline may only be tested in exceptional circumstances and considered after the main round of allocations has been made in March 2027.</p>
Waiting list	<p>A Local Authority waiting list, of those boys who sat the test for admission in September 2027, and who did not receive an offer from our school, or a more preferred school, will be held in strict oversubscription criteria order until the end of the first term of the academic year. Each child added to</p>

	<p>the waiting list will require the list to be ranked again in line with the oversubscription criteria.</p>
In Year Applications	<p><b>Year 7 (first term)</b> See Waiting List.</p> <p><b>January of Year 7-Year 11</b> From January of Year 7 onwards, parents living within Zone 1 may apply for a place directly to the school. Places will be offered in accordance with the published admissions criteria. Being added to the school's waiting list does not mean that a place will become available as in-year places normally only become available if a current student leaves the school.</p> <p>On receipt of an in-year application, the school will notify the Local Authority of both the application and its outcome, to allow the Local Authority to keep up to date with figures on the availability of school places in Birmingham.</p> <p>If a place becomes available, candidates on the waiting list in the appropriate year group will be invited to take a selective admission test appropriate to the year of entry and the place will be awarded to the highest scoring candidate above a minimum standard.</p>
Appeals	<p>If a parent/carer is refused a place at a school for their child, they have the right to appeal to an independent Appeal Panel set up under the School Standards and Framework Act 1998. Appeals for Bishop Vesey's Grammar School are administered by the School Admissions and Pupil Placements Service. Parents must not be refused the opportunity to make an application or be told that they can only be placed on a waiting list rather than make a formal application. Upon receipt of an in-year application, the admission authority, or the local authority if it is coordinating the admissions authority's in-year admissions, should aim to notify the parents of the outcome of their application in writing within 10 school days, but they must be notified in writing within 15 school days.</p>

Admissions Criteria	<p>Admission to the Sixth Form is based on performance in a student's best 6 GCSE subjects plus GCSE English Language and Mathematics (throughout this document this is referred to as 'Best 8').</p> <p>Points are awarded as follows:</p> <p>9 for a grade 9  8 for a grade 8  7 for a grade 7  6 for a grade 6  5 for a grade 5  4 for a grade 4  3 for a grade 3  2 for a grade 2  1 for a grade 1</p> <p>In order to qualify for the Sixth Form, pupils must have achieved at least 52 points as their Best 8 score and have attained the minimum criteria below for at least three A Level subjects that they wish to study. <p>Sixth Form Oversubscription</p>	<p>Priority will always be given to children who have studied their GCSE qualifications at BVGS, if they attain a Best 8 GCSE score of 52 points.</p> <p>We have 80 places allocated for external applicants.</p> <p>In case of over subscription, priority should be given to pupils based on the following criteria. The criteria will be applied in rank order:</p> <ol style="list-style-type: none"> <li>1.      Looked After Children/Previously Looked After Children</li> <li>2.      Pupils attracting the Pupil Premium, who achieve the qualifying score by rank order of standardised score but limited to no more than 20 children in this category</li> </ol> <p>Pupils attracting Pupil Premium are those who have been registered prior to the Sixth Form application closing date of 31 January 2027. The school will require evidence of Pupil Premium registration and reserves the right to withdraw the offer of a place if the offer has been made based on an incorrect, fraudulent or misleading application.</p>

	<p>Parents/carers of children attracting Pupil Premium must have ticked the Pupil Premium box when applying to Bishop Vesey's Grammar School by 31 January 2027. No alterations to this box can be made after 31 January 2027.</p> <p>Parents will need to provide evidence of Pupil Premium registration to our School Business Manager no later than the end of May 2027. Any evidence received after this date will be considered as late and will be considered after the main round of allocations has been made.</p> <p>3. Offers will be then made (depending on there being availability in an applicant's chosen subjects) to external pupils with the highest (Best 8) GCSE score.</p> <p>4. If distinguishing between external applicants with equal Best 8 subject scores, we will then apply the average score of the 3 stated A Level subjects or an equivalent subject, if it is not taken at GCSE.</p> <p>If data is still identical then a tie breaker will be applied based on a closest proximity to the school (See above for the calculation).</p>
Pupils opting for 4 'A' levels	Typically, around a quarter of our pupils take 4 'A' levels. To qualify to do 4 'A' levels, prospective pupils need to score a minimum of 66 points in their Best 8 GCSE subjects.

Appeals	If a parent/carer is refused a place for their daughter or son at Bishop Vesey's Grammar School Sixth Form, they have the right to appeal. Appeals must be sent in writing The Clerk to the Governors, Bishop Vesey's Grammar School. The Clerk will arrange an appeal within 30 school days of receiving the appeal.
